Objective:

The objective of preparing this document is to organizeeco-lodges in Iran, protecting native and traditional culture, increasing tourism products and creating a new kind of tourism destinations and attractions.

Scope:

Cultural heritage, handicrafts and tourism organization (ICHTO) and all the eco-lodges in the country

Definition:

The Eco-lodges are residential places in natural and native areas with maximum environmental consideration, compatible with local architecture, historical environment, and natural features of that area. These places will prepare a basis for developing tourism market with an acceptable quality in maximum interaction with local communities and climate diversity.

Documents:

- The guideline for establish, repair, complete, grade and rate of tourism facilities and operation supervising.
- Instruction for eco-lodges establishment and operation.
- Comments and suggestion of eco-tourism specialist and interested parties.

Minimum necessary requirements for eco-lodges standards:

The minimum necessary requirements for an eco-lodge to be qualified in an adequate degree are having a level of services and facilities that:

- a) Should be compatible with native architecture
- b) Meet the environmental necessities
- c) Provide secure accommodation

The eco-lodges are classified in 3 grades, A, B or C according to the acquired scores in evaluation process. In this process the issues will be evaluated in three general criteria as follows:

- a) Constructional issues, facilities and services and other related issues, 30% of total score
- b) Human resources issues, health and safety and other related issues,30% of total score
- c) Sustainability issues, environmental observations and cultural aspects and other related issues, 40% of total score

All the allocated proportions should be considered carefully in scoring process.

Score evaluation:

In evaluation process, the scores are ranged between 0 to 10 based on level of quality and favorability.

In eco-lodges with grade C, the minimum score for each issue should not be less than 1 and the mean of total score should be at least 2.

In eco-lodges with grade B, the minimum score for each issue should not be less than 4 and the mean of total score, should be at least 5.

In eco-lodges with grade A, the minimum score for each issue should not be less than 7 and the mean of total score should be at least 8.

The top grade can be awarded to the eco-lodges that provide facilities and services above the criteria limit of classification or perform very special activity for tourism sustainability.

2	Pre-agreement level: The Request for change or establish an eco-lodge should be discussed in the state committee of tourism planning, before referring to planning and finance deputy of ICHTO for the primarily approval. This committee is in charge for determining the need of state for eco-lodges. 3	Necessary documents and process for primarily approval: - A written request submitted by the applicant for establishing the eco-lodge - A formal copy of ownership certificate - Location sketch map - The report prepared by state committee of tourism planning referred to technical committee - Check and approve the location of the requested place and primarily approval by the deputy of planning and finance Note1: the eco-tourism expert should attend in the technical committee meeting. Note2: primarily approval for historical buildings and cultural heritage should be under agreement of cultural heritage deputy and other related departments.
