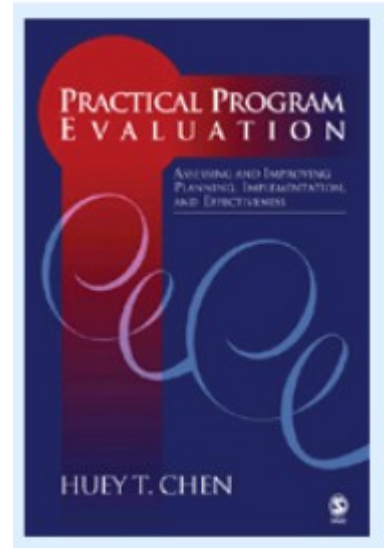




Huey Chen is a professor at the School of Public Health in the University of Alabama at Birmingham. Dr. Chen worked at the University of Akron until 1997, when he joined the Centers for Disease Control and Prevention (CDC) as chief of an evaluation branch. He took a leadership role in designing and implementing a national evaluation system for evaluating CDC-funded HIV prevention programs based in health departments and community-based organizations. Dr. Chen has contributed to the development of

evaluation theory and methodology, especially in the areas of program theory, theory-driven evaluations, and evaluation taxonomy. His book *Theory-Driven Evaluations* has been recognized as one of the landmarks in program evaluation. In 1998, he received the Senior Biomedical Research Service Award from the CDC. He is also the 1993 recipient of the Paul F. Lazarsfeld Award for contributions to Evaluation Theory from the American Evaluation Association.
